

National President's Report Brian Fulmer - Maryborough

Welcome to 2014 and what a difference 12 months makes. This time last year South East Queensland and Northern Rivers were recovering from the effects of flooding from Bundaberg and Maryborough to Grafton. As I pen this report, most of Queensland and New South Wales is still drought declared and the small dam at our home is the lowest I've ever seen it in the eight years

we've been here

But some things stay the same; we finished 2013 with bush fires in the Blue Mountains and started 2014 with them in Victoria, South and Western Australia, with record temperatures across the lower half of the country. Seeing the temperatures in South Australia and Victoria over the Xmas/New Year period was absolutely astounding. I have been in contact with a number of members to enquire as to their wellbeing and that of their fellow members, in the face of the bushfires threatening their districts. Lionel Mussell tells me he had to temporarily evacuate in some of the earlier fires but the recent fires are not threatening his new "digs". It's now the fifth anniversary of the Black Saturday fires in Victoria (5/2/09). How about Adelaide, sweltering one week &" drowning" the next.

I'd like to thank Bob Ireland for looking after a visiting "Pom". Steve Day, the chairman of 41ClubUK in Godalming, Surrey was visiting family in Victoria during early January. Bob was kind enough to take Steve and his family in tow with an invite to their Australia Day celebrations in Romsey. Steve was most appreciative and in his words ... "It has certainly been a warm welcome to Oz in every respect". It's great to see the spirit of international relations still alive and well.

During the festive season, Pam and I ventured down through the Central Coast of NSW and had the wonderful opportunity of enjoying some informal fellowship with members of Wyong Apex 40. It was great to catch up with old friends and in particular with members that I had been in Wyong Apex with. This was the follow on from an idea proposed by Nev and Margaret Bowman and Geoff Dunn in Brunswick Heads at the annual informal get together organised by Rob Noble of Alstonville last August.

Pam and I were also welcomed into the home of Margie Webb to attend a

meeting of the Crest Blue Mountains' Group. It was a lovely evening of fellowship with great company. Their President Bronwyn Berriman, who tragically lost her home in the 2013 bush fires, was unable to attend due to family commitments – but she was very much in our thoughts. Many a glass was raised, with the "boys" doing the BBQ and the ladies certainly looking after everyone. It is great to see a group so committed to their continuing fellowship under the Apex 40 banner and to be made so welcome.

As you would be aware from my last report I attended the 2013 Apex AGM. As a result of a face-to-face meeting with their new President, Kate Huth, I'm pleased to confirm that the Memorandum of Understanding (MOU) between Apex Australia Inc. and Apex 40 Australia Inc. has been renewed. There is no expiry date of this new agreement, a copy of which is on our website (www.Apex40.com). The new MOU is reviewable every two years at the Apex AGM following the change of Presidency at Apex40. Initial discussions have commenced with the Apex Foundation for a similar arrangement and I am hopeful of bringing this closer to fruition at the 2014 Rort.

Whilst on the subject of the 2014 Rort, there is still time to register and there are still have limited vacancies on the Post Rort tour (www.apex40.com/Rorts.html). If you haven't already registered for the Rort, March 31 is when final payments are due. If you have already registered and wish to now go on the Post Rort Tour, please contact either Col Ramsay or myself to change your status. A complete overview of the PRT appears later is this edition.

The term "Rort" can tend to raise an eyebrow or two for the uninitiated given its current usage in the press. However the original meaning of the term predates its current usage. To the best of my knowledge it is uniquely an Aussie slang noun based on the original English slang adjective of "rorte, rorty, raughty", meaning "enjoyable"; "fond of amusement & excitement". As an Aussie noun it came to mean "a rowdy, usually drunken party".

The term was first coined by Lionel Mussell (our first National President) in 1976 promoting the first Rort in the January 1976 edition of the Roaring 40's as "ROARING RORT:- (Means – Trick, Frolic, Spree, Orgy, Scheme – TAKE YOUR PICK).....our ROARING RORT to be held at Ballarat on March 12th/14 th' [1976]..... The term was the result of a combined brainstorming session by Kevin Frazer (first National Secretary) and Lionel. As Lionel says..." We've had frolics and sprees but I've yet to come across an orgy! ". So there you have it, the origins of the term Rort in Apex 40 terms.

At the 2014 Rort, Vice (Immediate Past) President Alan Bach stands down in terms of our Constitution. As you are aware Alan has lead us through the process of association and has made a considerable contribution. Apex 40 is now on a sound footing with insurance in place and a new Vice President will need to be elected in his place. Nomination forms will go out with the notice of meeting for the 2014 AGM. If you'd like to make a contribution to the Association or are aware of someone that would, please don't hesitate to nominate

I would also ask all Presidents to ensure that their Group has advised Secretary Col Ramsay of your current executives plus details of all members and their annual membership fees, due at the end of January, have been sent. If there is going to be a delay, please give either Col or myself the courtesy of letting us know (as some Groups have). A quick email is all that is necessary. Until we meet again in Adelaide, I'd wish you all a very happy Easter.

2014 ADELAIDE POST RORT UPDATE

THE HERITAGE & THE HISTORY

On Monday morning after breakfast we hop on our coach and leave Adelaide Shores for Tanunda in the Barossa Valley. Our first stop will be the German Bakery at Lyndoch for morning tea. Plus you'll have the opportunity to buy any of your favourites like donuts, danishes, berlinas, kitchener buns and custard tarts just to name a few! The remainder of the day in Tanunda includes a private Vineyard Tour and Wine Tasting at Jacobs Creek. Learn more about what goes into making great wines through participating in a walking tour of their display vineyard. A tutored wine tasting will follow, incorporating seven wines and basic wine education on the sensory evaluation process.

Lunch will be served at the Tanunda Club, winner of the 2012 South Australian Club of the Year. An iconic venue in the Barossa Valley, the Club's history is a story of people, the spirit of community; and triumph over adversity. We then continue on to a private Grand Insight and Tasting Tour of Seppeltsfield through the spectacular gardens, palms and heritage buildings. Learn of the early pioneering spirit of the Seppelts family and their profound influence on the Australian wine industry. The tour includes the barrel cellar, distillery and underground blending cellar, followed by a tasting from their table and fortified wines in a private area and is followed by a private tasting concluding with Seppelt's Para 21 year old Vintage Tawny.

Later in the afternoon we visit Maggie Beer's Farm shop for an opportunity to pick your own collection of goodies from Maggie's famous delectables; choose from pates, cheeses, olives, wood fired bread and a glass or wine or bubbles. Creating short run products based on the best quality produce in season is how Maggie started with the Farm Shop.

Both Jacobs Creek & Seppeltsfield are private tours away from the "bus crush", Accommodation for the next three nights is at the Barossa Motor Lodge with dinner and breakfast included.

Tuesday morning we depart for the bamboozling Mintaro Maze in the Clare Valley for morning tea. This living hedge maze, consisting of over 800 conifers, features fountains, twists and turns to trick even the most committed explorer. And when you do find your way out, there's plenty more to enjoy, with a range of giant-sized games featuring local Mintaro slate. From there we visit Martindale Hall, a treasured secret hidden away in the Clare. Experience the grandeur

and ambience of this authentic 19th century Georgian mansion. Built in 1879 for a 21 year old sheep farmer, Edmund Bowman Jnr, it was designed as a home for entertainment and sporting activities. It is in near original condition, including furniture and fittings.

Lunch is at the Magpie & Stump hotel in Mintaro. This hotel has been licensed since 1851 when, it was a wild pub catering for the needs of the itinerant bullock and mule drivers who passed through the town. In recent times it has been carefully revived as a typical English village pub. From there we tour Sevenhill's celebrated old stone winery and cellar door, stately St Aloysius' Church, the College building, spacious gardens and the surrounding vineyards which provide visitors with a memorable experience of a welcoming and tranquil place. As the only remaining Jesuit-owned winery in Australia, residing Jesuits are actively involved in Sevenhill's ongoing development in partnership with lay staff who share the ethos of building the Jesuit Mission to support works of charity and compassion throughout Australia.

From there we again step back in time at Bungaree Station which began on Christmas Day 1841, when George C Hawker and his brothers, James and Charles, selected it as the site for their "head station". They had purchased 2000 ewes from NSW, and on advice of the explorer, Edward John Eyre, went looking for sufficient good land along the Hutt River. They found "good drinkable water at a depth of 8 feet and plenty of it" and named the property "Bungaree", after the aboriginal name for the area. Bungaree became the headquarters of an extensive property, running 100,000 merino sheep. As a result, the property was like a small village, with its sandstone Homestead, Woolshed, Shearers' Quarters, Station Store, Manager's House, District Council Chambers, staff cottages and a Church.

Keeping in the theme of times long past, Wednesday sees us visit Burra, a pastoral centre and historic tourist town in the mid-north of South Australia. It lies east of the Clare Valley in the Bald Hills range, part of the northern Mount Lofty Ranges, and on Burra Creek. The town began as a single company mining township that, by 1851, was a set of townships (company, private and government-owned) collectively known as "The Burra". Today the town continues as a centre for its surrounding farming communities and, being one of the best-preserved towns of the Victorian era in Australia. Lunch including traditional Cornish Pasties, will be

provided by the local Burra Bakery.

We depart Tanunda on Thursday morning for morning tea at the National Motor Museum at Birdwood which houses Australia's most important collection of vintage, veteran and classic motorcars and motor cycles - more than 300 in fact. It's set in a beautiful complex by the River Torrens in Adelaide's picturesque hills, 50 kilometres from Adelaide. The Museum is much more than a collection of vehicles - it is a social history of the way we were, the way we are now and the way of the future.

On return to Adelaide we pay a visit to Haig's Chocolates, at 150 square metres this must surely be Australia's largest chocolate shop. Enjoy special chocolate tastings and complimentary coffee or tea while selecting from an extensive range of factory fresh chocolates and confectionery, including their famous chocolate frogs, truffles, fruit centres, fudges and bars. Bulk packs, special lines and some chocolate seconds are also available. After that sweet indulgence, we'll have lunch at the Largs Pier Hotel before returning to Adelaide Shores for a well-deserved rest. Dinner that evening will be a mobile roast in the Pavilion BBQ area at Adelaide Shores.

The last day of the Post Rort Tour is a luncheon cruise aboard a real side paddle wheeler along the mighty Murray, a must see for history buffs. There are few rivers in the world that are as rich with history and heritage as our own Murray River in South Australia. You will feel the history as you snake along the river with expert commentary from your River Murray Master at the helm. You will love cruising along this natural border that separates New South Wales and Victoria and which just happens to be the world's 16th longest river at 2,530km.

The environmental beauty of the Murray will leap out at you from the river banks, which are home to a range of unique flora and fauna including Black Swans and Red-Rumped Parrots; as well as Koalas, Western Grey Kangaroos and more. You will enjoy a magical and memorable time aboard the Captain Proud which features an air-conditioned dining room and licensed bar, where you can grab a drink and toast your good fortune on these fabled waters. We then return to Adelaide Shores for our last tonight together for a mobile casserole dinner in the Pavilion BBQ area before we say our farewells.

It took some time and some heavy discounting, but I sold Marg's beautiful 1880's German Lipp piano, the old weighing machine from the pharmacy, a leather rocking chair, leather-topped coffee table, marital bed, American pedal organ and a coal-fired iron. At least five trips to the op shops reduced stocks of books, ornaments, china and toys. Trevor took two truckloads of miscellany to the tip and the family helped out by taking some of Margaret's treasures, but still the unit is piled high with 23 chairs, 29 paintings, and saddest of all two filing cabinets full of Margaret's family history records. I have made one distribution to each side of the family and a lot to the Genealogical Institute but there is a lot still waiting for a caring owner.

Hedley Sutton is perfect. The unit is roomy and sunny, the people are very welcoming and there are many outings and dining opportunities to take away the monotony of dinner for one. They are putting on a high tea in a couple of weeks which sounds very pukka. My only problem is remembering what I'm supposed to be doing and where. There is a men's shed in the basement which should be just right to make a batch of home brew as the weather warms up. Letting the family home for a year seemed a good idea at the time rather than selling, but it does raise problems. I left the workbench and some shelving in the garage which I thought would be useful for the tenant but I was told that would have to go as she needed all the space. She must have more stuff than me. Good old Trevor came good with a truck so away went another load to the tip."

"I suppose Christmas and January went well – it's hard to think back that far. My first without Marg was hard to take – instead of just saying "That looks nice, dear" or "What would you like me to do now", I had to think ahead and do everything myself. Christmas cards were hard, but I deter-

mined I'd start on Margaret's friends first because there were more of them - I always marvelled at how she would regularly remember to call her old cronies for a chat – my instincts are to only ring people if I've got something to ask them or tell them – men don't seem to have such a talent for fostering relationships. I must work at it more – I don't want to be a lonely or grumpy old man "
